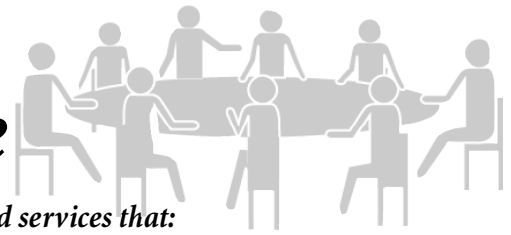


Community Service Boards At Your Service



Community Service Boards (CSB) in Virginia provide programs and services that:

- Insure the growth and development of infants who have or are at risk of developmental disabilities, birth to age 3.
- Enable children and youth with mental illness, mental retardation, and substance abuse disorders to remain in their homes, schools, and communities.
- Work to preserve and enhance families.
- Meet the residential, outpatient, and day support needs of citizens with severe mental illness.
- Offer opportunities for occupational and residential independence for citizens with mental retardation.
- Respond to psychiatric emergencies.
- Promote resiliency in youth and communities through prevention and education activities.
- Support the efforts of schools, Department of Social Services, law enforcement agencies, and courts in a coordinated manner.
- Prevent further incidence of mental illness, mental retardation, and substance abuse.
- Effectively treat citizens with substance abuse disorders.
- Support the care of elderly citizens with mental disabilities and their families.
- Assist families in caring for members with mental disabilities.
